



Deaf or Hard of Hearing Support 2021-2022 Program Profile

Description

The Deaf or Hard of Hearing classroom program is designed for students, ages 5-21, with an educational and medical diagnosis of hearing impairment. The program supports students whose degree of hearing loss and communication needs require intensive support regardless of modality of communication, including auditory/oral, American Sign Language, and total communication. All classes provide academic instruction and instruction to promote communication and language development. The elementary program includes instruction in self-help and readiness skills, in addition to coaching in self-advocacy, assistive technology, and the use of an interpreter where appropriate. The secondary programs also include instruction in self-advocacy related to hearing loss, communication and assistive technology. Transition plans for high school students may include pre-vocational, vocational, and post-secondary skills. Depending upon the student's schedule, instruction may also include advocacy related to ADA, 504 Plans, accessing interpreter and agency services, and Deaf community and culture. Students engage in learning in inclusive settings as much as possible.

Placement Criteria

- Educational and medical diagnosis of hearing impairment
- Cannot be adequately supported at level 1 & 2 services
- Requires intensive support and total communication, which may include spoken language and/or American Sign Language
- May require extensive case management, including interagency coordination
- May require D/HH peer group to promote social-emotional development and interactions

Exit Criteria

IEP Team decision, based on participation in regular education environment; transfer of skills in general education curriculum or alternate curriculum; independent communication skills

Location

District classroom with access to same age peers for inclusion purposes

Staffing

- Full time teacher (maximum of 8 students - 1:8:1)
- Full time paraprofessional

- Specialized training for all staff
- Foundational support from sign language interpreters to provide students access to communication in general, non-instructional, school activities
